Laura Muellerleile

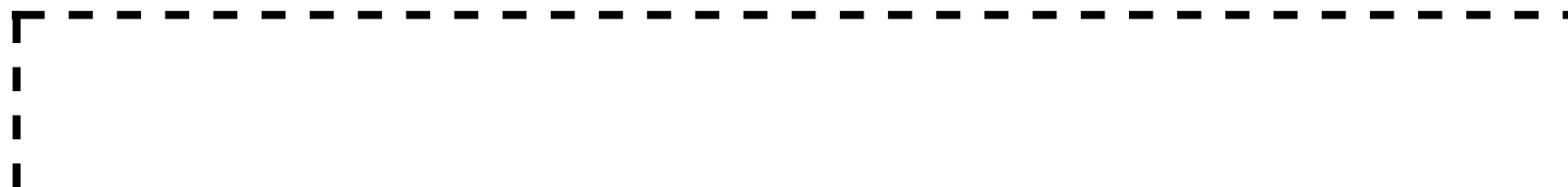
Laura joined our board in March as our incoming Treasurer. She is an onsite manager at Park Crest Harbour Island for FirstService Residential.
